Vocational education will be integrated into the curriculum starting in class 6. Students in higher education are free to select any subject from a variety of streams, including the arts. The policy must prepare instructors who comprehend the pedagogical requirements to facilitate the transition to the humanities, sciences, sports, and vocational disciplines.


#### **Examination And Assessment :**

Although there is less of a focus on libraries in policy, libraries should still be recognized for their significance as information hubs and libraries, and the National Education Policy 2020 should place more emphasis on the resources and services that libraries provide.

# **Adequate Library Staff :**

It will be crucial to have enough library employees on hand in NEP 2020 on (21.9) to

manage the services provided to teachers and the general public and create suitable career trajectories and CPD for them. In addition, all currently operating libraries will be strengthened; reading rooms and rural libraries will be established in underprivileged areas; reading materials in Indian languages will be widely accessible; children's libraries and mobile libraries will be opened; social book clubs will be established throughout India and across subject areas; and increased cooperation between educational institutions and libraries will be fostered.

The Policy also states that libraries must stock a sufficient number of high-quality resources in sufficient quantity to accommodate readers from all subject areas. To create a different kind of value for libraries for the public and society, it is also suggested that schools and organizations lack adequate space and facilities for libraries. As a result, they are focusing on organizing a specific area and providing resources for users until 2025.

## Suitable infrastructures for the library:

Ensuring adequate and appropriate infrastructure will enable all interested individuals to participate in adult education, lifelong learning, and study. One of the main steps in this direction will be to use public libraries, school buildings, and after-hours and weekend spaces for enrichment and community engagement activities, as well as adult education courses that are, whenever possible, well-designed and equipped with information and communication technology. Sharing of infrastructure for school, higher education, adult, and vocational education, as well as other community and volunteer activities, will be necessary to ensure the effective use of physical and human resources and to encourage synergy across these five types of education and beyond. These factors make Adult Education Centres (AECs) a potential addition to other public establishments like HEIs and career training centers.

# Availability and accessibility of books:

The NEP 2020 placed a strong emphasis on the public's and readers' access to highquality books and resources for study and education. To foster the habit of reading in our communities and educational institutions, it is imperative to enhance the accessibility and availability of books.

The Policy suggests strengthening and modernizing all communities, organizations, and educational institutions, including public libraries, colleges, and universities, to provide a sufficient supply of books that meet the needs and interests of every student. Books and other resources for various and unique reader types in society, such as people with disabilities and other differently-abled people, will also be made available under the NEP 2020.

# The role of central and state Government:

The national and state governments are in charge of creating the libraries, providing funding for their operations, and making sure that books are affordable and available to everyone in the nation, including those who live in rural and isolated areas and socioeconomically disadvantaged areas. Agencies and institutions in the public and commercial sectors shall develop plans to raise the caliber and recognition of literature written in every Indian language.

# Digital libraries and online resources are included in the NEP 2020:

Online resources for digital libraries are included in the NEP 2020, and efforts will be





made to improve library book accessibility online and expand the reach of digital libraries.

# Provision for strengthening all existing Libraries:

The NEP 2020 asks for the support of all currently running libraries, the creation of reading rooms and rural libraries in impoverished areas, the launching of children's libraries and mobile libraries, the establishment of social book clubs throughout India and subject areas, and the promotion of more extraordinary collaborations between educational institutions and libraries. Libraries currently need to modify their offerings to take into account the increasing ICT use in all fields. The Indian government is focusing on offering excellent online learning materials for both higher education institutions and classroom instruction.

The Indian government's Digital India initiative and vision inspired and supported the Digital Library's online education and learning capabilities. The development parameters and supportive nature of NEP 2020 are ideal for Indian libraries
