Initially its jurisdiction extended to Assam, Nagaland, Manipur, Tripura, Mizoram and Arunachal Pradesh. Later, after the reorganization of states and the establishment of separate High Courts, its jurisdiction was mainly limited to Assam, Nagaland, Mizoram and Arunachal Pradesh. The Gauhati High Court has played an important role in strengthening the judicial traditions and legal framework of Northeast India since its inception. The library of this High Court has also been a major source of legal information for judges, advocates and researchers since its early years.

Initially, the Guwahati High Court Library functioned in a traditional format, providing a collection of printed legal texts, Acts and judgments. Over time, the library enriched its collection and included various Indian and foreign legal texts. When information technology started entering libraries in the second half of the twentieth century, the Guwahati High Court Library also tried to adopt this change. Gradually, the catalogue started to be digitised, online databases were subscribed to and initiatives were taken towards making judicial judgments available in digital form.

In the twenty-first century, when the Internet and the World Wide Web spread widely, the High Courts created their official websites. The website of the Guwahati High Court was also developed in this context. This website not only became a medium for sharing information and administrative activities of the court, but it also provided an opportunity to present the services of the library in digital format. Today, the website of the Guwahati High Court Library has facilities such as online database of judicial decisions, Acts and Manuals, notifications, e-resources, online catalogue and user guidance. This website is a concrete step towards the digitisation of the judiciary and is proving to be helpful in ensuring equal access to justice.

This study will not only be limited to identifying the digital services available on the website, but it will also tell what is the nature of these services, how comprehensive they are

On the international plane, Johnson (2018), in his appraisal of the websites of US Court Libraries, observed them to be top-notch sources of judicial information. By the same token, Lee and Park (2019) equally lauded the multilingual digital services in Korea as highly beneficial for users across the globe.

Digital Libraries and their Role in Legal Research:

The definition of access to information and knowledge has changed in the digital age. Libraries are no longer limited to printed books and journals but are meeting the needs of researchers more effectively by providing e-books, e-journals, legal databases, online catalogues and multimedia sources in digital format. The biggest advantage of digital libraries is that they eliminate the limitations of time and space. Users can access the required information from any place, at any time.

The role of digital libraries is particularly important in the field of legal research. The availability of judicial decisions, Acts, Constitution, legislative reports and legal comments in digital format provides quick and accurate information to researchers, advocates and judges. Online legal databases such as SCC Online, Manupatra, and Hein Online etc. have made judicial research more systematic and simple. This not only speeds up the decision making process but also improves the quality of legal reasoning.
